Dear Mr. Elstein:

On March 8, 2018, the North American Electric Reliability Corporation (NERC) and Western Electricity Coordinating Council (WECC) filed a joint petition seeking approval of proposed regional Reliability Standard BAL-004-WECC-3 (Automatic Time Error Correction). NERC and WECC also requested approval of the associated effective date for the proposed regional Reliability Standard, violation risk factors and violation severity levels, as well as retirement of currently-effective regional Reliability Standard BAL-004-WECC-2. Proposed regional Reliability Standard BAL-004-WECC-3 seeks to maintain Interconnection frequency and to ensure that time error corrections and primary inadvertent interchange payback are effectively conducted in a manner that does not adversely affect the reliability of the Western Interconnection.¹

NERC's filing was noticed on March 13, 2018, with interventions, comments and protests due on or before April 12, 2018. Southern California Edison filed a timely motion to intervene, raising no issues.

Such action shall not be deemed as recognition of any claimed right or obligation associated therewith and such action is without prejudice to any findings or orders that have been or may hereafter be made by the Commission in any proceeding now pending or hereafter instituted by or against the Electric Reliability Organization or any Regional Entity.

This order constitutes final agency action. Requests for rehearing by the Commission may be filed within 30 days of the date of issuance of this order, pursuant to 18 C.F.R. § 385.713 (2017).
