Notice of Withdrawal of Appeal With Prejudice

Pursuant to Rule 216 of the Federal Energy Regulatory Commission's ("FERC" or the "Commission") Rules of Practice and Procedure, and in compliance with the Joint Settlement Agreement between Constellation Energy Commodities Group, Inc. ("Constellation") and the Texas Regional Entity and approved by the North American Electric Reliability Corporation ("NERC") ("Settlement Agreement"), Constellation hereby submits this notice to withdraw its Request for Appeal from NERC's decision to register Constellation as a Generator Operator in the NERC Compliance Registry, filed on July 11, 2008 in the captioned proceeding ("FERC Appeal").

I. WITHDRAWAL OF THE FERC APPEAL

The Settlement Agreement provides that Constellation will "voluntarily withdraw with prejudice" its FERC Appeal within thirty days of a "final, non-

appealable order" approving the Settlement Agreement "as submitted to [the Commission] or as modified in a manner acceptable to the Settling Parties ("Final Order")." The Commission made the Settlement Agreement effective as of the date of the Settlement Order, August 17, 2009, but granted Constellation's request for an extension of time to allow the deadline for filing requests for rehearing to expire prior to withdrawing the FERC Appeal. Because the time period for filing requests for rehearing has expired, and no requests for rehearing have been filed, the Settlement Order is now final and non-appealable. Constellation hereby notifies the Commission of its withdrawal, with prejudice, of the FERC Appeal.
